ORDER:

- 1. The "Gokula Krishna College of Engineering, Behind RTC Depot, Sullurpet, Nellore Dist" was given Temporary affiliation for running Degree courses during the academic year 2009-10 vide Procs.(1) read above.
- 2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2010-11 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2010-11 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted an Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee for recommendations for granting Temporary affiliation for the academic year 2010-11. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2010-11 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before January, 2010.

- 1. 116 faculty members only are available against the requirement of 140.
- 2. At least 50% of faculty should be ratified by the University.
- 3. Principal appointment is to be ratified by the University.
- 4. Faculty Cadre ratio should be maintained at 1:2:6 (Professor, Associate Professor, Assistant Professor)
- 3. Under the circumstances as stated above, the Vice-Chancellor is pleased to Grant **Temporary Affiliation** to "Gokula Krishna College of Engineering, Behind RTC Depot, Sullurpet, Nellore Dist" sponsored by "Sri Krishna Educational Society, Arora Colony, Banjara Hills, Hyderabad" to offer Degree Course in the following disciplines with the intake shown against each for the Academic Year 2010-2011 as detailed below:

- 3. Anti-ragging measures to be taken strictly in accordance with UGC regulations on curbing the menance of ragging in Higher Educational Institutions, 2009 (F.1-16/2007 (CPP-II))
- 4. Regular meetings of College Academic Committee and Governing Body shall be conducted.
- 5. College website is to be created.
- 6. Digital library should be established and NPTEL e-learning resources should be procured.
