ORDER:

- 1. The "Gokula Krishna College of Engineering, Behind RTC Depot, Sullurpet, Nellore Dist" was given Temporary affiliation for running Degree courses during the academic year 2014-15 vide Procs.(1) read above.
- 2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2015-16 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2015-16 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee for recommendations for granting Temporary affiliation for the academic year 2015-16. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2015-16 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before 30-12-2015.

- 1. To apply for NBA accreditation
- 2. Computer Student ration is to be maintained as per norms
- 3. Faculty cadre ratio is to be maintained as per norms
- 4. Faculty student ratio is to be maintained as per norms in UG programs and in M.Tech PE & MCA program
- 5. At least 50% of faculty appointments have to be ratified by the University.
- 6. E-Class room has to be provided
- 7. E-Learning resources have to be procured
- 8. Internal marks are being given liberally
- 9. CC cameras have to be installed in exams halls.
- 10. Internal Quality Assurance Cell is to be established
- 11. Enterpreneur Development Cell has to be established
- 12. NSS Unit has to be established

- 13. Principal should be Chief Superindentent of all exams and not exam branch incharge
- 14. Governing body meetings should be conducted in the presence of University Nominee
- 15. Most of the faculty are with B. Tech. qualification
- 16. Aadhaar and PAN number has to obtained by all the teaching staff
- 3. Under the circumstances as stated above, the Vice-Chancellor is pleased to Grant **Temporary Affiliation** to "Gokula Krishna College of Engineering, Behind RTC Depot, Sullurpet, Nellore Dist" sponsored by "Sri Krishna Educational Society, Arora Colony, Banjara Hills, Hyderabad" to offer the following courses with the intake shown against each for the Academic Year 2015-2016 as detailed below:
