ORDER:

1. The “Gokula Krishna College of Engineering, Behind RTC Depot, Sullurpet, Nellore Dist” was given Temporary affiliation for running Degree courses during the academic year 2017-18 vide Procs.(1) read above.
2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2018-19 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2018-19 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2018-19 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, within 02 months.

- a. Laboratories should be improved as per the curriculum needs
- b. At least 50 % of the faculty appointments have to be ratified by the University
- c. Faculty cadre ratio is to be maintained as per AICTE norms
- d. Sufficient number of titles, volumes, National & International journals should be procured and made available for library.
- e. The college should apply for NBA, NAAC status
- f. Sports facilities should be provided and Physical director should be appointed immediately.
- g. Anti-ragging measures should be taken strictly and anti-ragging posters should be made available in the college premises
- h. Barrier free environment should be created
- i. R.O. system should be maintained properly for supply of drinking water
- j. Governing body meetings are to be conducted in the presence of University nominee
